Survey among the top 1000 companies in Romania

In preparation for the conference, CRJ has invited top 1000 companies in Romania as turnover and number of employees to complete a questionnaire. At the end of the conference, the results of the questionnaire will be made public. We will learn together how many companies have a code of ethics, have internal anti-corruption procedures, and have conflicts of interest procedures and what kind of public policies agree.

The conference will be followed by a **Seminar of Experts**, which will take place on **March 6, 2013** at the Romanian-American University. The seminar will benefit from the participation of experts from the Ministry of Justice. During the seminar, using a SWOT grid, the participants will analyze the most interesting policy proposals in ethics and compliance. In this respect, CRJ invites interested independent experts to send to the address etica@crj.ro, until February 15, 2013, a document within 3 pages with proposals of public policies that can stimulate Romanian companies to invest in ethics and internal compliance systems.
