DIRECTIONS OF ACTION AND **PROGRAMS**



The Centre for Legal Resources (CLR) operates through its team of lawyers and human rights experts on multiple levels:

- We conduct monitoring visits, take on cases of rights violations of institutionalized individuals with disabilities, and go through all the procedural steps necessary for the realization of these rights;
- We make proposals for improving the legislative framework regarding human rights, or for creating standards where none exist;
- We follow the implementation of public policies in the field of human rights and integrity, and identify vulnerabilities in the system.

ANTI-DISCRIMINATION

The programme, active since 2003, has started to focus less on the adoption of legislation in the field of anti-discrimination and more on the effective implementation of anti-discrimination legislation.

ADVOCATE FOR DIGNITY

The programme was launched in 2003 as a pioneering approach in defending the rights of institutionalized people with intellectual and/or psychosocial disabilities, through a system of unannounced, regular monitoring visits aimed at identifying and bringing to the public authorities' attention the way in which the law regarding the protection of the rights of institutionalized people with intellectual and/or psychosocial disabilities is being enforced.

JUSTICE AND RULE OF LAW

The programme aims to improve citizens' access to justice, to contribute to the strengthening of institutions that ensure the protection of human rights and the rule of law.

OBJECTIVES

- equality mainstreaming in Romanian laws and policies, especially those with a direct impact on vulnerable groups
- an increased capacity of civil society organizations and the members of vulnerable groups to combat discrimination, and a Romanian public which is more aware of discrimination and its effects.

To achieve these objectives, the programme includes activities such as: Advocacy; Monitoring and reporting; Training and capacity building; Watchdog activities.

PROJECTS

■ Non-discrimination, Beyond Words (2021-2023)

The project aimed at raising awareness about the high level of Romanian society to accept and internalise hate speech within the public space and to capacitate citizens to identify, report and combat hate speech, including through de-constructing of bias towards various groups vulnerable to discrimination (myth busting of bias), providing tools and easy access to information.

The project was funded through the Active Citizens Fund Romania, financed by Iceland, Liechtenstein, and Norway through the EEA Grants 2014-2021.

■ INTEGRIS: Integrated Support for Human Rights (2021-2023)

The project aimed to support and strengthen the capacity of vulnerable groups to exercise and defend their fundamental rights and to combat discrimination and it addresses to people belonging to groups vulnerable to discrimination, especially women, Roma and LGBT+ people, from all over the country. It was also aimed at lawyers and legal specialists, representatives of NGOs working with people belonging to vulnerable groups, public authorities providing support services, as well as the general public.

The project was carried out by ACTEDO, the project coordinator, in partnership with the Centre for Legal Resources (CLR), and was funded through the Active Citizens Fund Romania, financed by Iceland, Liechtenstein, and Norway through the EEA Grants 2014-2021.

PROJECTS

CHAT for Victims (2022-2024)

The project was developed with the objective to improve access to information and support for persons with disabilities who are victims of crime. The project will achieve this goal by developing a live-chat service adapted to the communication needs of persons with disabilities, with emphasis on persons with voice, hearing, intellectual and psychosocial impairments/ disabilities.

WHY CHAT FOR VICTIMS?

Access to information and effective communication are essential for persons with disabilities (PwDs) who are victims of crime in order to participate effectively in criminal justice process. Unfortunately, **the existing means of support are usually hard to access or are completely inaccessible to PwDs.**



So the project "CHAT for Victims" is created to **facilitate accessing the information and support for victims of crime who are PwDs**, with a focus on people who are hard of hearing or deaf, as well as people with sight, speech and voice impairments and those with intellectual and psycho-social disabilities.

The 10 informational materials, created with the purpose of supporting the prevention and combating of hate speech in Romania, by providing a tool for deconstructing prejudices against certain minorities and groups vulnerable to discrimination, have been translated into English, in order to reach as wide an audience as possible.

STUDIES

The Centre for Legal Resources (CLR) has launched the report "2021-2022. An Overview on Hate Crime and Hate Speech. Romania - country profile." Based on a methodology used in similar reports produced by CLR for the years 2015-2020, it presents and analyzes the relevant national legal framework, data on hate speech and hate crimes available in Romania, as well as measures for the prevention and combating of hate speech and hate crimes for the period January 2021-June 2022.



The research report has also been translated into English and disseminated internationally.

NON-DISCRIMINATION, BEYOND WORDS EVENT



February 2023, Bucharest. CLR organized the National Conference "Hate Crimes and Hate Speech. The Situation in Romania: Past and Present" where we discussed the main data and conclusions of the CLR Study "2021-2022. An Overview on Hate Crime and Hate Speech. Romania - country profile", about the legal framework, data collection, processing, reporting, and training, presenting both problems and solutions.

INTEGRIS EVENT



June 2023, Cluj-Napoca. The Equality and Human Rights Action Center (ACTEDO), in partnership with the Centre for Legal Resources (CLR) and with the support of the Cluj Bar Association, organized the country's first **National Pro Bono Forum**, a major conference dedicated to fundamental rights and social justice. CLR delivered a presentation on discrimination, hate speech, and hate crimes.

CHAT FOR VICTIMS RESULTS

CLR conducted a national research study aimed at understanding the needs of individuals with disabilities when they access support and use live chat services, focusing mainly on the barriers they face, as well as best practices and ways to improve the accessibility of support services.

The research was qualitative and included:

- An analysis of documents (legislation, studies, reports)
- 3 focus groups with representatives and organizations for the rights of individuals with hearing, speech, and visual impairments, and the rights of individuals with intellectual and psychosocial disabilities
- 4 individual interviews with representatives of the organizations "Supereroi printre noi [eng:Superheroes Among Us]", the White Cane Association, and ACTEDO (Equality and Human Rights Action Center), as well as with a representative of the National Agency for Equal Opportunities in Romania (ANES).



WORKING IN PARTNERSHIP

March 2023, Budapest. CLR participated in a working meeting with project partners, which included a training course managed by the Validity Foundation on how to conduct focus groups and interviews with individuals with disabilities.



September 2023, Madrid. CLR participated in a two-day meeting, where partners attended a training session held by Victim Support Europe, as well as work visits to organizations in Spain that offer various support services for victims and victims of crime, including persons with disabilities.

The training session covered the following topics:

- Awareness and understanding of disabilities
- Vulnerabilities to crimes of persons with disabilities
- Empathy and effective communication
- Remote care

JUSTICE AND RULE OF LAW



PROJECT HUMAN RIGHTS SITUATION, UP TO DATE (2022-2024)

The project aims to increase citizens' awareness of human rights, equal treatment and the rule of law in Romania and to strengthen the capacity of civil society and opinion makers/professionals, by creating the necessary tools and access to expertise, to identify, report and challenge human rights violations, institutional practices that are detrimental to human rights, and gaps in legislation and law enforcement.

RESULTS

Main activities:

- The experts at CLR have consistently monitored legislative initiatives, i.e. formal but also informal (media and social media) debates in society.. During this reporting period, they have issued 14 opinions on topics related to human rights and access to rights (www.crj.ro/starea-drepturilor-omului/ - an independent human rights expertise platform available online, on the CLR website, and social media).

Fundraising and Awareness Campaigns

 - Drafting and submitting to authorities an observation report on how the law is applied in the visited social care home;
 - Requesting a response from the authorities;
 - Notifying responsible parties when we identify abuses against the rights of institutionalized individuals with intellectual and/or psychosocial disabilities;
 - Media advocacy to promote the rights of institutionalized individuals with mental disabilities;
 - Legislative proposals.

ADAPTJUST - Accessible Justice for People with Disabilities

The aim of the project is to improve the implementation of judgments of the European Court of Human Rights (ECtHR) and decisions of the Committee of Ministers of the Council of Europe (CoE) concerning the rights of persons with intellectual and psychosocial disabilities deprived of their liberty. The project will increase the capacity of the magistrates and the civil society to defend the rights of the persons with disability and will pilot five actions within a mechanism of protection .



FREE TO DECIDE. Transition from Guardianship to Supported Decision Making for Persons with Disabilities

The project aims to increase the capacity of persons with mental disabilities, stroke and dementia to exercise their rights and to maximize their autonomy. The project will develop and pilot four models supported decision making services in collaboration with public and private social service providers.



ENABLE - Facilitating Inclusion and Access to Justice for Defendants with Intellectual and Psychosocial Disabilities

The project aims to improve knowledge of participation barriers faced by defendants with intellectual and/or psychosocial disabilities in the criminal justice system.



LITI-GATE - Strategic Litigation as a Gateway to Address the Rights of Persons with Disabilities in the European Union

The project brings together 6 partners from 5 countries with the aim to promote enforcement of the EU Charter of Fundamental Rights with strategic litigation activities to address breaches of the fundamental rights of persons with intellectual and/or psychosocial disabilities.



July 27, unannounced monitoring visit

- 4 persons with severe disabilities lying on dirty mattresses soiled with feces, urine, and blood, with flies on them, unable to defend themselves or ask for help (nonverbal and incapable of moving); one person was in an advanced state of malnutrition (skin and bones), with hip lesions, covered in flies, smelling strongly of feces, another person in the basement was covered in feces and blood on the face and hands, the other 2 persons couldn't move or communicate
- one person living in the basement, who could move and had left that space, to the ground floor of the building
- 2 severely ill persons, trapped in a room of approximately 3 m², without ventilation, without lighting, in a bed. Access to this space was blocked by a metal table on which bricks were placed.



NATIONAL ADVOCACY

- **20 unannounced monitoring visits**
3 criminal complaints filed by CLR



- **DIICOT acknowledges the active legal standing of CLR**

for the defense of the rights or legitimate interests of persons with disabilities in two criminal cases

- **Order regarding the reimbursement of psychiatric reevaluation services**

Following the handling of several complaints, CLR has submitted multiple notifications to the competent authorities: the Ministry of Health, the National Health Insurance House, the College of Psychologists, etc. As a result of these efforts, along with other submissions from the courts on the subject, in August 2023, Joint Order No. 2692/1889/2023 was published in the Official Gazette. Through this order, the provisions of Order No. 3432/2128/2022 were amended.

TRAINING

- **A meeting for the formation of a justice intermediary network**

Initiating the process of forming a network of specialists in the field of mental health to collaborate with courts and prosecutors' offices by training 30 psychologists/psycho-pedagogues selected at the national level.

- **Formation of a network of specialists for victim assistance**

Writing a methodology for the operation of a call center dedicated to victims with intellectual and/or psychosocial disabilities institutionalized in centers, medico-social units, hospitals/psychiatry departments.

- **Workshops on supported decision-making**

- Two online workshops addressed to judges, with 20 judges from the jurisdiction of the Oradea Court of Appeal.
- An online workshop aimed at social workers, with 212 participants.
- A workshop in person in collaboration with the National Mental Health and Anti-Drug Fight Center, with 19 participants.
- A training session with representatives of NGOs and public authorities from pilot counties and persons with disabilities, coordinated by Professor Michael Bach, with 27 participants.

- March 16, 2023, with 14 participants (center managers, psychologists, social workers, occupational therapists, socio-educational animators, medical and rehabilitation staff, specialty personnel coordinators from the Maramureş County Directorate General for Social Assistance and Child Protection - Day Center for Adults with Disabilities in Grivitei, Maramureş County, Calineşti Social Assistance and Child Protection Department, Enablement and Rehabilitation Center for Adults with Disabilities in Filipeştii de Târg).
- March 17, 2023, with 43 participants (center manager, specialty personnel coordinators, pedagogues, social workers, psychologists, kinesiotherapists, head of case management service, and legal counselors from the Prahova County Directorate General for Social Assistance and Child Protection).



● Planning a National Action Campaign

- The TV spot and radio recording were filmed at the end of 2023.
- Over 500 posters were printed in accessible language, intended for centers, hospitals/psychiatric departments, DGASPCs (General Directorate for Social Assistance and Child Protection), and police inspectorates.
- Additionally, 15,000 informative flyers were printed, targeting persons with disabilities who are institutionalized, as well as authorities.

The radio-TV spot, posters, and flyers aim to promote the "Ceasul Bun" (The Good Clock) application and the cerajutor.ro platform. The overall objective is to maximize the autonomy of institutionalised individuals and facilitate access to appropriate tools to report any abuses and exercise their rights.

The mobile application "Ceasul Bun" (The Good Clock), in the form of an accessible questionnaire, is dedicated to supporting institutionalized individuals or employees in residential care homes, hospitals, or other similar institutions to report situations of physical or emotional abuse, or neglect.

Web Platform

The web platform complements the mobile application "Ceasul Bun" and addresses the same needs identified over 20 years of expertise in the field, namely the lack of adequate tools through which vulnerable individuals (those with intellectual and/or psychosocial disabilities, as well as those with neurological conditions, institutionalized) can have effective access to justice (to be able to report criminal acts of which they are victims, to claim their rights, or to request a reassessment of protective measures instituted).


